Diana has also substantial experience in structuring and negotiating cross-border transactions as well as the acquisition and divestiture of corporate divisions.

On the fund formation front, she addresses a full spectrum of legal and business challenges that arise throughout the life cycle of a fund (incorporation, liquidation, mergers). In her experience, she has already set up and approved an ESG venture capital fund under Article 8 of the European regulation on disclosure of information relating to sustainability in the financial sector.
